## **A summary of the fifth meeting of the ODF Forest Carbon Stakeholders Working Group - Monday March 10, 2008 in Portland, OR.**

**Discussion on the Draft Letter to the WCI Offsets Sub-committee:**

- A special thanks to Mike Schnee for authoring the first draft letter to summarize who we are and what we are working on to the WCI Offsets Sub-committee. Everyone should have received this letter as an attachment from Mike Schnee on Thursday 3-6-08.
- The group felt the letter contained too much detail for what we currently have agreement on. General consensus was to strike most of the contents of Section No. 2 and to rework the document in a more brief form.
- The remainder of the meeting was spent working through the framework of a revised draft of the letter. John Audley graciously volunteered to collect the group's thoughts on his laptop during the discussion and will work with the drafting sub-committee to re-write the letter and hopefully have it out to the group for comments or approval either later this week or early next week.
- Our goal is to have this letter finalized and sent out ASAP and not devote any time to it next meeting.

**Next Steps:**

- Re-write the draft letter to the WCI Offsets Sub-committee to submit as soon as possible that outlines what the group is working on, where some agreement has been reached, and issues we are still working on. Group members expect to see this revised draft soon and be prepared to initiate a quick turn-around on comments so we can send this to the WCI Offsets Sub-committee ASAP!
- Continue working through the second draft of the synthesis paper identifying the issues we can come to some agreement on and the more difficult issues which will require more time and discussion.

**Next Meeting:**

- Work through the second draft of the synthesis paper identifying agreement and the issues or concepts where we will have to focus more time and effort on reaching agreement.
